- Joint control is the contractually agreed sharing of power to govern the financial and operating policies of an economic
- Associate is an enterprise in which the company has significant influence and which is neither a subsidiary nor a joint venture of the company.
- Significant influence (for the purpose of this schedule) means participation in the financial and operating policy decisions of a company, but not control of those policies. Significant influence may be exercised in several ways, for example, by representation on the board of directors, participation in the policy making process, material inter-company transactions, interchange of managerial inter-company transactions.personnel or dependence on technical information. Significant influence may be gained by share ownership, statute or agreement.
